# **CEC Member Spotlight — Andy McArthur**

I grew up in Friendship Tennessee, a small town in Crockett County. My father telecommuted while working for S&K Sales out of Connecticut. My mother was a stay -at-home-mom. I was fortunate to have both parents around almost my entire childhood. I have three older sisters and one younger brother. There is a 23 year gap between the oldest and youngest of my siblings. However, we are a very close family. We all worked together on the farm and enjoyed the tranquil country life.

I became active in sports at around 7 years old when my mother signed me up for taekwondo lessons. I was crazy about the movie Karate Kid and she thought a few lessons would be a good reward for doing well in school. She figured I would take a few classes and eventually move on to something else. But, I kept going to class and received my first degree black belt a little over five years later. After about another year and a half I received my second degree black belt. I also played football, basketball, volleyball and baseball along with riding horses. I was extremely busy with a game, tournament, and/or horseshow nearly every weekend. Amazingly, I cannot remember a single event where I did not have at least one person in the stands cheering for me. I am blessed to have such a supportive family.

Our bond was put to the test when I was 16. My father traveled some for his work and had gone to Frankfurt Germany just after my sophomore year. A couple days after he arrived in Germany he suffered a heart attack. We received a call from his employer that he was in the hospital and stable. S&K Sales actually sent the family to Frankfurt to be by his side. Unfortunately, he was sedated the entire time we were there and passed away a little over three weeks after the first heart attack.

I inherited a lot of responsibility at a young age. I knew I could not replace my father's income in the traditional sense. But, I did learn how to buy and sell real estate through our dealings in farm land. My mother and I continued farming while buying and selling farm land, houses, and commercial properties. We had some successes and some failures. The key to everything was that we kept working together. We remained a cohesive family unit. However, the real estate crash basically put an end to our operations.

Even before the real estate crash, I joined the Navy to study nuclear engineering. My family has a long military background and it seemed like the logical thing to do. I fully intended to fly but my eye sight would not allow me to enter flight training. So, I stuck with nuclear power and picked up a few other specialties along the way. Upon leaving the Navy I put myself through flight school where I earned a commercial pilot certificate. I taught karate through flight school and had several professional pilots as students. I quickly learned the importance of job stability. I watched several of my karate students that had 20 or more years of commercial pilot experience get laid off. Most of them took up non-flying careers just to keep an income. On the other hand, most of my fellow student pilots at the flight school were attorneys or accountants. I realized the accountants could fly when they wanted and had stable careers. Accounting seemed like a better alternative than gambling on a flying career that could easily end at the drop of a hat.

After flight school, I moved back to West Tennessee where I attended Jackson State Community College. The people there were great and pushed me to excel in many areas. I became a tutor in math, chemistry, physics, accounting, economics,

and Spanish. I received an Associates of Arts in Psychology and an Associates of Science in Accounting in the spring of 2009. I was also awarded the Transfer Trustee Scholarship to attend Lipscomb University to finish my undergraduate degree. I learned about the Master of Accountancy program when I arrived at Lipscomb and the Trustees agreed to fund my tuition through the entire program assuming I maintained an appropriate GPA. I had to drop psychology for the time I spent at Lipscomb, but I finished the Master of Accountancy program in May of 2012.

I began working as an Internal Auditor I for the Tennessee Department of Treasury on June 1, 2012. I honestly could not be happier. I have a great leadership team that supports me in my work and has given me numerous opportunities to develop professionally. I am currently attending Middle Tennessee State University in pursuit of a couple more graduate degrees; MA in Psychology - Behavior Analytics and MBA in Aerospace Business Administration. Also, I am taking the CPA exam and have passed one of the four parts. I stay busy to say the least. But, I believe my goals are attainable with the support of my family in West Tennessee and my Treasury family here in Nashville.


